Plan for temporary removal of a pupil from the classroom in accordance with NRS 392.4645:

**Alternative Learning Center (ALC)**

When a student engages in behavior that seriously interferes with the ability of the teacher to teach the other pupils in the classroom and with the ability of the other pupils to learn, the student may be removed from the classroom pursuant to NRS 392.4645. The deans and/or principal of the school shall provide an explanation of the reason for the removal of the student to the student and offer the student an opportunity to respond to the explanation. Within 24 hours after the removal of a student, the principal's office shall notify the parent or legal guardian of the student.

The student will be assigned to the Alternative Learning Center (ALC) which is separated, to the extent practicable, from students who are not assigned to a temporary alternative placement. The student will study under the supervision of appropriate personnel of the school and will be prohibited from engaging in any extracurricular activity sponsored by the school.

**2008-2009**  
**SCHOOL RULES**

Listed below are some basic rules to guide Carson High School students. The rules are itemized because they represent difficult areas. **Violations of any of the following school rules will result in appropriate disciplinary action as determined by the appropriate staff member.**

1. Students are expected to respect members of the school staff.
2. Students must carry and provide proper identification to school personnel upon request. CHS student body ID cards are free. CHS student body activity cards are \$25. Replacement cards are \$5.
3. **Visitors are not allowed to attend classes.** Only staff, parents/guardians, and enrolled students attending scheduled classes are allowed on school grounds. Students will not be allowed to loiter on the school grounds or in the school buildings. A Trespass Warning will be issued to unauthorized individuals on a first offense; on a second offense individuals will be subject to arrest per NRS 207.200.
4. Students must obtain administrative approval for any meeting or assembly held on school property and any printed matter they wish to distribute or post on school property.
5. No student may leave the campus for any reason during class without obtaining a pass from the Attendance Office. Permission from a teacher, alone to leave, is not sufficient.
6. Students in the hall without a hall pass or who leave class without permission are subject to progressive disciplinary action.
7. Eighteen-year-old students must conform to the same requirements as students who have not attained the age of eighteen if they are to attend the regular day classes. They may excuse their own absences, with official professional documentation being required to avoid a No Grade.
8. **The school cannot assume responsibility for lost, stolen, or confiscated items, which may include money, electronic equipment, school issued supplies, equipment, books, cell phones, and iPods, etc.**
9. Students representing the school in athletics, band, drill team, cheerleaders, and other school groups must conform to standards established by the coaches or sponsors of the activity and by the Nevada Interscholastic Activity Association. Students must have a current paid student body card in order to participate in any activity. All fines and fees **MUST** (No Exceptions) be paid in order to participate in any extra-curricular activity. Students involved in school-sponsored activities, either on or off campus, are subject to the Carson High School Discipline Code, and the right to represent agreement.
10. The following items are prohibited on campus or at a school activity; caps, cigarette lighters, firecrackers, laser lights, matches, pepper spray, snowballs, tobacco products, water guns, Replica fire arms, water balloons, etc. Furthermore, **dangerous weapons** or any items (jewelry/apparel) capable of doing bodily harm are prohibited at school or at school-sponsored events. Prohibited items will be confiscated.
11. **\*\*Cell phones or any other electronic devices must be turned off and remain out of sight during scheduled class time.**
12. Skateboards, skate shoes and roller blades may not be ridden on school campus. Skateboards, skate shoes and roller blades must be put in the student's locker. At no time are they to be used in the building or on the school grounds. Failure to abide by these rules will result in confiscation and/or suspension.
13. **Acceptable Use Policy (AUP) -- In order to use any computer, students must have on file a parent/student AUP signed agreement.**
14. **Food and Drink are not permitted in any of the school's computer labs nor in a classroom when the mobile labs are being utilized.**
15. Lockers are considered to be school property and may be searched at any time. School officials may also search students, their backpacks, purses, cell phones, and vehicles if there is reasonable suspicion that the student has violated school rules or civil law. A witness will be present at each search.
16. Carson City School District prohibits behavior that is intimidating, harassing, threatening or disruptive and/or which is associated with gang membership, including solicitations to join or become associated with a gang.
17. Hazing of students on school property, at school-sponsored activities, and/or on school district transportation is prohibited. Any student reported hazing another student will be subject to disciplinary action.
18. **Only Carson High School students are eligible to attend Carson High School dances, except the Senior Prom. For this dance, up to 70 guests must be screened and approved by the administration. Guest identification must be presented at the time of the ticket purchase. No guests 21 years of age or older will be allowed to attend the Senior Prom.**
19. Students are to keep the campus clean.
20. Students may be placed in alternative educational programs based on credits, age, behavior, attendance, and health.
21. It is inappropriate for students to gather in such a manner that their presence obstructs the orderly movement of pupils and staff.
22. A student enrolled in Carson High School on a variance is considered a guest of the school. As a guest he/she is strictly held to the Carson High School Dress and Behavior Code. Our expectations of your child are to maintain satisfactory grades (GPA 2.0), attendance and behavior. Should your child fail to maintain satisfactory grades and attendance, or violate the Dress and Behavior, you will receive a written warning indicating that another violation will result in your child's variance being revoked. A more serious violation will result in an immediate revocation of your child's variance. Carson High School uses revoking a variance as a disciplinary action. However, this action may also include a suspension to be served at your child's regularly districted school.
23. Couples should show proper respect for each other by avoiding excessive displays of affection on school grounds.
24. Student records are confidential information made available only to the parent/guardian and/or the student. Parents/guardians wishing access to their student's records may do so by contacting the Principal's Office, and providing proper identification.
25. **SEC. 9528. ARMED FORCES RECRUITER ACCESS TO STUDENTS AND STUDENT RECRUITING INFORMATION.**

(1) ACCESS TO STUDENT RECRUITING INFORMATION- Notwithstanding section 444(a)(5)(B) of the General Education Provisions Act and except as provided in paragraph (2), each local educational agency receiving assistance under this Act shall provide, on a request made by military recruiters or an institution of higher education, access to secondary school students names, addresses, and telephone listings.

(2) CONSENT- **A secondary school student or the parent of the student may request that the student's name, address, and telephone listing described in paragraph (1) not be released without prior written parental consent.** This form is available to parents in the guidance office.

26. Random **Preliminary Breath Test** will be given at all school sponsored dances. Furthermore, any student suspected of being under the influence of alcohol at any school sponsored event is subject to a **Preliminary Breath Test**

27. **Students are not allowed to sell items for any reason without obtaining administrative approval.**

### **Alternative Learning Center (ALC)**

When a student engages in behavior that seriously interferes with the ability of the teacher to teach the other pupils in the classroom and with the ability of the other pupils to learn, the student may be removed from the classroom pursuant to NRS 392.4645. The deans and/or principal of the school shall provide an explanation of the reason for the removal of the student to the student and offer the student an opportunity to respond to the explanation. Within 24 hours after the removal of a student, the principal's office shall notify the parent or legal guardian of the student.

The student will be assigned to the Alternative Learning Center (ALC) which is separated, to the extent practicable, from students who are not assigned to a temporary alternative placement. The student will study under the supervision of appropriate personnel of the school and will be prohibited from engaging in any extracurricular activity sponsored by the school.

### **SUSPENSIONS**

**Carson City School District Regulation Number R-525** lists the following suspension period as general guidelines, which may be varied by the proper administrator at his/her discretion pending circumstances. When city, state or federal laws have been violated, referral will be made to the proper legal authorities. **An offense deemed serious by the proper administrator may result in expulsion as stipulated by Nevada Revised Statute.**

**Judicial Board:** Students could be given the option to appear before a jury panel of their own peers to hear minor infractions and receive an imposed student sanction. An honored sanction replaces possible consequences from the Dean of Students and will not reflect on a student's discipline record.

#### **ALCOHOL, CONTROLLED SUBSTANCE, POSSESSION and/or SALE**

Students who are in possession (under the influence), and/or who consume alcohol an illicit substance, drug related paraphernalia, a chemical or organic substance to induce euphoria or hallucinations, and/or prescription drugs without a prescription 10 to minimum 90 days.

#### **ARSON:** Students involved in the willful destruction or defacing of school

property, or the property of others through the act of burning. Furthermore, the offenders' parents or guardians will be held responsible for repairing or replacing damaged school property, 180-day suspension or expulsion.

#### **ASSUALT and/or BATTERY:** Students who attempt an assault/battery upon a teacher, or other school district employee, or students, 4 to 90 minimum days, Home Suspension or Alternative Placement.

#### **DISRESPECT FOR SCHOOL RULES:** 2 minimum 90 days, home suspension.

**Acceptable Use Policy (AUP):** Students using computer's inappropriately will suffer classroom penalties including possible loss of internet privileges. Any action which results in damage to computers or corruption of the system or any display or publishing of obscene or inappropriate images or language will result in administrative disciplinary action.

**DISOBEDIENT/INSUBORDINATION:** Students who are disobedient, insubordinate or defiant toward school employees, either in language or action.

**FALSE INFORMATION:** Students who falsify information either verbal or written, to any school district employee.

**UNAUTHORIZED AREA:** Students that are found in an unauthorized area on school grounds.

**Habitual Offender:** Students who have been suspended three or more times are considered habitual offenders and suspension record is cumulative and will be maintained for his/her high school career. All disciplinary records will continue to the next school year. Once declared a habitual offender, the next disciplinary infraction will result in a 90 day suspension.

#### **DRESS CODE VIOLATION:** Students who violate the Carson High School dress code 1<sup>st</sup> offense-warning contract – 2<sup>nd</sup> 2 days.

#### **ENDANGERMENT:** Students involved in the endangerment of students, staff or the school or for incitement of any nature, 2 days to minimum 90.

#### **EXCESSIVE TARDY:** Students who are excessively tardy to class, detention, Saturday School, ALC 2-4 days.

#### **FORGERY/ ALTERING OR ATTEMPTING TO ALTER SCHOOL RECORDS OR GIVING FALSE IDENTIFICATION:**

Students who falsify information either

verbal or written, to any school district employee, 4 to 90 days.

#### **GANG ACTIVITY:** Students involved in any gang activity while on school ground, 1<sup>st</sup> offense 90/inf gang contract, and/or minimum 10 to 90 days.

#### **TRUANT/HABITUAL TRUANT:** Any child deemed truant will be declared A habitual truant when deemed truant three or more times within the school year and shall be subjected with a referral to a law enforcement agency, attendance contract.

**HAZING:** Students who harass other students with humiliating tasks or practical jokes, 4 to minimum 90 days. NRS 200.605

**INAPPROPRIATE BEHAVIOR:** Students who continually display inappropriate behavior which is disruptive to the educational process or to the operation of the school, 2-4 days.

**INAPPROPRIATE LANGUAGE/MATERIALS:** Students using obscene language or gestures, or writing obscenities or displaying obscene materials, 2 to 4 days.

**Felonious Acts:** 180-day suspension or expulsion for any felonious act committed on school property or while involved with any school sponsored activity.

**PROPERTY DAMAGE:** Students involved in the willful destruction or defacing of school property, or the property of others, 2 to minimum 90 days. Furthermore, the offenders' parents or guardians will be held responsible for repairing or replacing damaged school property. NRS 393.410

**SEXUAL HARASSMENT:** Students involved in sexual harassment of any student, or school district employee, or authorized visitor, 2- minimum 90 days.

**TOBACCO POLICY:** Students using or possessing any form of tobacco on school property, 1<sup>st</sup> offense, tobacco contract, 2<sup>nd</sup> offense, 2 days.

**THEFT and/or POSSESSION OF STOLEN PROPERTY:** Students involved in stealing on school grounds and/or offenses that could include damage, theft or possession of school or private property, 4 – 90 days.

**TRAFFIC VIOLATION:** Students involved in a traffic violation on campus 5- 10 days off campus, possible Carson City County fine.

**VIOLATE CONTRACT:** Students who violate their Contract(s) will be subject to the terms of the contract.

**VIOLENCE, EXTORTION, HARASSMENT, Incitement – STAFF/STUDENT:**

Students who direct any threatening gestures or verbal threats, extortion and/or harassment toward any school district student or employee and/or school building, 4 to 90 days.

**WEAPON:** Students who bring to school and/or in possession (student's person, locker, or vehicle) of articles, weapons (A knife with a fixed or lockable blade more than 2 ½" in length as measured from the tip of the blade to the tang (hinged end) of the knife), counterfeit firearms or any item that shoot a projectile and/or articles capable of doing bodily harm to endanger or harm Carson High School students or staff, 10 days unless it is an NRS violation (90 – 180 days- expulsion NRS 392-466).

**Disciplinary Probation:** Should a student be involved in another serious incident during his/her enrollment at Carson High School, he/she will be suspended home or to an alternative placement of Opportunity School for a minimum of 90 school days.

Students on suspension are not permitted to attend or participate in school-sponsored activities.

Opportunity students are trespassed twenty-four (24) hour/ seven days a week and advised not to go on or near any Carson High School campus at anytime during their suspended term.

All students who are suspended from Carson City School are not allowed to participate in extracurricular/sport during the suspension term.

On a first offense Nevada statute provides for a 90-day suspension or expulsion for **(1) battery which results in injury of a school employee, and (2) sale or distribution of a controlled substance**. On a first offense Nevada statute provides for a 180-day suspension or expulsion for **possession of a dangerous weapon**. For a second offense, the student must be permanently expelled from school.

To cooperate fully with the discipline procedures of other schools, Carson High School will not accept students who are under suspension/expulsion from another school until such suspension/expulsion has been completed. If a specific term is not indicated for the expulsion, the student will not be permitted to enroll until the end of the current semester.

**Appeal Process -Parents/guardians who wish to appeal the suspension of their student may do so by notifying the principal at 283-1930.**

**Drug Dogs:** Carson City School District has an agreement with the Carson City Sheriff's Office to allow their officers to bring Drug Dogs into CHS. Dogs check automobiles, lockers, and classrooms. Individuals are not searched; however, backpacks, briefcases, and other individual items are. If and when a "hit" is made, parents will be contacted and if a controlled substance is found, the student will be arrested.

A Drug Awareness/Intervention Program is available for students and their parents/guardians. This program provides an option, upon completion of the program, which may decrease the number of suspension days.

**Community Service:** Students who owe restitution to CHS, are truant, or involved in any other disciplinary infractions, may be assigned to the after school Carson High School Community Service work program if deemed necessary by the appropriate administration

## STUDENT DRESS CODE

**Purpose of the dress code:** is to promote a learning environment that is respectful and free from distractions. To put it simply, the priority here is to teach and learn, not to be on display.

**What is the dress code?:** That clothing must be MODEST. Also that clothing and personal appearance must not promote or glorify illegal, promiscuous, gang-related or racially-biased slogans or behaviors. What's that mean? No sex, drugs, alcohol, profanity, racist or gang-related messages on your clothes.

In order to create a learning atmosphere that is respectful and free from distractions, the following list of **DON'TS** must be adhered to:

- No undergarments (bras, underwear, camisoles, etc.) should be visible, ever (walking, standing, seated)
- No skin visible at the midriff
- No cleavage
- No halter-tops, backless, strapless garments, or spaghetti straps (nothing less than 1")

- No head coverings or sunglasses worn in school buildings
- No see-through or sheer clothing
- No shorts or skirts so short that rear ends are not well covered, even when going upstairs.
- No bare feet
- No face painting concealing identity in any form is allowed, except when part of an approved school activity.
- Red/Blue shoe laces
- Chains or other heavy apparel
- No gloves
- No bandanas of any color (including bandanas used as headbands)
- No "trench" style coats
- No excessively baggy clothes

School safety is an important concern; therefore, also prohibited are clothing, jewelry, accessories, notebooks or any other item which, because of the way it is worn, its trade mark, or any other characteristic (such as color), carries known gang connotations. All items may be confiscated.

### ATTENDANCE

According to Nevada Revised Statute 392.040, the parent, legal guardian, or other person, in the state of Nevada, having control or charge of any student shall be required to send the student to school during times that the public school is in session. The Carson City School District is responsible for maintaining an accurate attendance record for each student enrolled and for notifying the student, parent or legal guardian of absences, which may be cause for the student to lose credit or to be placed in an alternative learning environment.

Nevada Revised Statute 392.130 states, "Any student shall be deemed truant who shall have been absent from school without a valid excuse." In accordance with this statute, the appropriate school administrator shall require from the parent of each child who has been absent from school or from class for any reason a written statement or verbal communication of the cause of absences. School authorities reserve the right to verify such statements and to investigate the cause of each absence. A truancy write-up reflects that legal proceedings have begun.

According to Nevada Revised Statute 392.140, "Any child shall be declared habitual truant who shall have been deemed truant three or more times within the school year."

**Educational neglect occurs when a student is missing school on a regular basis and the absences are affecting the student's performance in school. The parent is aware the student is missing school but is not forcing the student to attend or may even be keeping the student home for personal reasons and may be writing notes to excuse the absences for the student. State law only allows for a student to be absent from school if he/she is physically or mentally unable to attend. (NRS 432B.330)**

A school administrator must report to appropriate authorities, infractions of law regarding student attendance. Habitual truants and habitual excused absences will be reported to the Ron Wood Family Resource Center, and parents/guardians who aid and abet truancy may be reported to the Carson City Sheriff's Department/District Attorney.

### ATTENDANCE POLICY

It is imperative that students maintain an excellent attendance record for their four years of high school. Attendance and academic achievement are part of a student's permanent record. **It is the parent's/guardian's responsibility to regularly monitor their child's attendance.** A parent/guardian is required to notify the Attendance Office within 3 days after the student returns to school.

To assist parents with their student's attendance, parents will be notified by phone each day when their child has been absent from 1 or more classes.

1. Students absent for **6 or more days FIRST semester** or **8 or more days SECOND semester** from an individual class may receive No Grade in lieu of a passing grade for the semester. Students absent for more than the required attendance days in a semester that are failing will receive a failing grade for the semester. Submitting a copy of professional documentation of an appointment would assist in the possibility of a student's ability to avoid a No Grade situation.
2. Appointments (**away from school**) will be considered absent when a student is not present in class for more than 30 minutes.
3. Teachers will attempt a conference with their students at least one absence prior to issuing a no grade.
4. Students can appeal a NO GRADE for the semester by contacting the Carson High School Appeals Committee in the Attendance Office (283-1910). **The deadline for filing an appeal for a No Grade is two weeks into the following semester. The decision of the Appeal Committee/Judicial Board is final.**
5. **No Grades for the semester will not affect a student's GPA; however, the student will have to repeat required classes.**

### ATTENDANCE GUIDELINES

1. A homebound study program is available to students who have a doctor's excuse to do their studies at home or in a hospital setting. Contact the Attendance Office at 283-1910 or Special Services at 283-2350 for further information.
2. **On the first day of the absence, a parent/guardian should telephone the Attendance Office giving the reason for the absence. The only acceptable reasons for excused absences are:**
  - a. personal or serious family illness

- b. death in the family or funeral of a close friend
  - c. professional appointments
  - d. out-of-town trip which is arranged with the school in advance and which, in the judgment of the school administration, is justified
  - e. bona fide religious holidays
  - f. absences cleared by an administrator.
- In the case of truanancies, teachers are not required to provide make-up work for those classes.
3. It is the student's responsibility to have absences excused promptly. **If absences are not cleared within three school days after the student returns to school, they could be considered truant.**
  4. **Whenever a student must leave school early, he/she must report to the Attendance Office to sign out.** Permission from a parent/guardian must be obtained before a student is released.
  5. Students who become ill need to report directly to the Nurse's Office after obtaining a written pass from their classroom teacher. The nurse will make the necessary arrangements for this student to leave campus or return to class.
  6. Every student must be in attendance in all classes to participate in any interscholastic activity or practice for that school day. Professional appointments will be honored for an absence the day of a contest or activity. All professional appointment excuses must be accompanied by verified documentation. All absences must be cleared by the athletic director or appropriate administrator for the student to be able participate.
  7. Students who are tardy thirty (30) minutes or more to a class will be charged with an absence for that period; however, late students must report to class after checking in at the office.
  8. **Tardies - (Tardies will be excused with professional documentation only).** Two warning bells, one bell 5 minutes before the tardy bell, and one bell 1 minute before the tardy bell rings to keep students apprised of the time remaining before the tardy bell. Students who are tardy face the following penalties; 3<sup>rd</sup> & 4<sup>th</sup> tardies – teacher imposed penalties; 5<sup>th</sup> tardy – 2 lunch detentions; 6<sup>th</sup> tardy – 4 lunch detentions; 7<sup>th</sup> tardy –After School Community Service- 2 hours; 8<sup>th</sup> tardy –After School Community Service- 4 hours; 9<sup>th</sup> tardy – 2 days ALC with required parent conference. ; 10<sup>th</sup> tardy – 4 days ALC with required parent conference In addition, tardy sweeps will be run periodically.
  9. Students will serve one lunch detention for each time they are caught in a tardy sweep (discipline will become progressive if student is a repeat offender).

#### **PARKING GUIDELINES      2008 - 09 school year**

1. **All students who park on school campus during school hours (7:00am – 2:00pm) must have an assigned space. The space is \$20, if purchased prior to the first day of school, \$25.00 on or after August 25. Only one space per student.**
  2. **Parking a vehicle on school property is a privilege, not a right.**
  3. An assigned space does not guarantee a space for the day.
    - Inclement weather
    - Special events
- ❖ During these occasion open parking will be granted
4. Parking space will only be issued to students with a valid Nevada driver's license at time of purchase.
  5. Students are not to go to their vehicles during school hours without proper authorization.
  6. Students who leave campus without the proper authorization will be subject to disciplinary action including potential loss of parking privileges.
  7. The safe operation of motor vehicles is required. Vehicles must not travel in excess of 5 miles per hour on campus. Seat belts are required for drivers and all passengers.
  8. Carson High School is not responsible for damages to, or theft from, vehicles. Students are cautioned NOT to leave valuables in their vehicles. Parked vehicles should be left with window closed and doors locked.
  9. A student's vehicle is subject to search in the case of reasonable suspicion regarding the presence of drugs, alcohol, stolen property, or other contraband in the car.
  10. Parking fees are **NOT** refundable.
  11. Students who operate a motor vehicle on campus should fully understand their duties and responsibilities. Students who violate parking or driving regulations are subject to any or all of the following consequences:
    - Revocation of parking privilege
    - Ticketing
    - Towing and storage of the vehicle, at the owner's expense
    - Disciplinary action
    - Criminal charges as prescribed by law
  12. Handicapped parking is only available as needed on an assigned basis
  13. All students must clear all fees and fines prior to applying for a parking space. Permits will not be issued to students with outstanding fees or fines.
  14. All Carson City Municipal Codes pertaining to operating a motor vehicle and parking a motor vehicle have been adopted by the Carson City School District. Violations may be enforced by designated school safety officers and law enforcement officers.
  15. Red zones indicate no parking, standing or stopping at anytime. Yellow zones indicate loading and unloading for passengers and materials only and vehicles may park up to 25 minutes.
