Mission Statement

The mission of Pioneer High School is to provide alternative routes to success for young adults in the Carson City School District.

Principal's Highlights

A school bond was passed to update and expand the PHS campus in the next two years to address the increase in enrollment and the number of graduates.

- PHS was awarded by the Department of Education as a Nevada Highlighted School based on achievement and graduation in 2011.
- The school leadership team was invited to present an overview of curricular programs at the Nevada Department of Education Mega Conference.
- The number of graduates increased by 38% from 2010 to 2011 with another projected record number of graduates for 2012.
- CTE classes in criminal justice and construction were added for students to obtain dual credits for college and high school units.
- PHS increased its curricular offerings to 250 different courses through small classroom style and online options.
- Students at PHS utilizing Carson Online courses obtained a 96% passing rate.
- The Project Discovery and PHS partnership helped provide off campus activities leadership and character development options.
- PHS added 2 additional (NWAC) Accredited High School Diplomas: Advanced Placement Diploma and Honors Diploma.
- Flexible scheduling options include: 4 semester small classroom style sections, hybrid, and part-time/full-time online education formats.




